RESOLUTION NO. 2009-218

A RESOLUTION APPROVING THE PROPOSED TICKET PRICES FOR THE
COMING "SWEET SIXTEEN" GAMES OF THE PHILIPPINE
COLLEGIATE CHAMPIONS LEAGUE (PCCL) ON NOVEMBER 28,
2009.

WHEREAS, this sangguian is in receipt of an indorsement dated October 26, 2009 from the Office of the City Mayor relative to the herein request from the Ormoc City Sports Council for the passage of a resolution approving the proposed ticket prices for the coming "Sweet Sixteen" Games of the Philippine Collegiate Champions League (PCCL) which will be hosted by the City Government of Ormoc through the Ormoc City Sports Council, in cooperation with the Ormoc City Schools Sports Organization (OCSSO) on November 28, 2009;

WHEREAS, the Philippine Collegiate Champions League (PCCL) is a national basketball league intended to consolidate the different college-level tournaments throughout the country with the goal of crowning a national collegiate basketball champion, one which can truly claim to be the only and real national collegiate champion;

WHEREAS, the PCCL leadership believes that Ormoc City can be a capable and worthy host for the said "Sweet Sixteen" Games, which will be participated by the respective champion basketball teams coming from Cebu and Manila;

WHEREAS, it will be recalled that Ormoc City hosted the PCCL Inter-Zonal Championship Games last November 9-12, 2008 and such hosting was so successful that the PCCL leadership commended our management of the games;

WHEREAS, the organizers, Ormoc City Sports Council and the Ormoc City Schools Sports Organization (OCSSO) will shoulder and pay all expenses related to the event and the remaining balance will be returned to the Ormoc City Schools Sports Organization after all expenses shall be paid and a financial statement will be submitted to the concerned agencies for their information;

WHEREAS, in order to defray the possible expenses that will be incurred during the tournament, the local organizers intend to sell tickets for the championship games at the following prices:

50.00	Upper Box	(Yellow Seats)

WHEREAS, as required under Ordinance No. 64, Series of 1997, otherwise known as "AN ORDINANCE GOVERNING THE OPERATION AND MANAGEMENT OF THE ORMOC CITY SUPERDOME, AND THE FIXING OF THE RENTALS, FEES AND OTHER CHARGES FOR THE USE THEREOF", the permission of the Sangguniang Panlungsod is needed, hence this request from the Chair of the City Sports Council, Honorable Ruben R. Capahi;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by the City Councilor Sotero M. Pepito, Chairman, Committee on Economic Enterprise, duly seconded by City Councilor Mariano Y. Corro;
