NUEVO, TO FILE AN OPPOSITION TO THE APPLICATION FOR APPROVAL OF ADJUSTMENT IN THE RATE UNDER THE RULES FOR SETTING ELECTRIC COOPERATIVES' WHEELING RATES (RSEC-WR) WITH PRAYER FOR PROVISIONAL AUTHORITY FILED BY LEYECO V BEFORE THE ENERGY REGULATORY COMMISSION.

WHEREAS, this Sanggunian is in receipt of a copy of the APPLICATION FOR APPROVAL OF ADJUSTMENT IN RATE UNDER THE RULES FOR SETTING ELECTRIC COOPERATIVE' WHEELING RATES (RSEC-WR) WITH PRAYER FOR PROVISIONAL AUTHORITY filed by LEYTE - V before the Energy Regulatory Commission;
