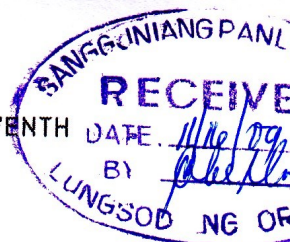



ADOPTED, November 12, 2009.


