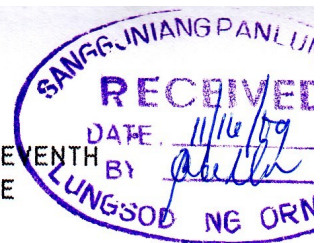

RESOLUTION NO. 2009-224

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC THE MEMORANDUM OF AGREEMENT (MOA) BY AND AMONG THE LGU OF ORMOC, THE ORMOC SUPREME LIONS CLUB AND PAROLE AND PROBATION OFFICE - ORMOC FOR THE MAINTENANCE OF CLEANLINESS OF THE ORMOC BAY SHORELINE.

WHEREAS, this sanggunian has received an indorsement dated November 12, 2009 from the Honorable City Mayor in connection with the Memorandum of Agreement (MOA) by and among the City Government of Ormoc, the Ormoc Supreme Lions Club, and the Parole and Probation Office - Ormoc for the maintenance of cleanliness of Ormoc Bay Shoreline and further requesting for authority to sign the same;

WHEREAS, the agreement is otherwise known as "Adopt Ormoc Bay Shoreline" and involves a continuing clean-up drive along Ormoc Bay to be undertaken by the members of the Ormoc Supreme Lions Club and the staff of Parole and Probation Office - Ormoc with the consent, support and approval of the city government for a period of One (1) Year commencing on November 14, 2009;

WHEREAS, the concerned parties have also the option to provide alternatives to inform the public of the importance of such undertaking to maintain and preserve the environment;

WHEREAS, this august Body believes that the Memorandum of Agreement (MOA) is beneficial to the city;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Ruben R. Capahi, duly seconded by City Councilor Sotero M. Pepito; be it


ADOPTED, November 12, 2009.
