RESOLUTION NO. 2009-226

A RESOLUTION STRONGLY OPPOSING THE INCREASE OF TERMINAL
FEE RATES FROM P20.00 TO P150.00 TO BE CHARGED AT THE
ORMOC CITY DOMESTIC AIRPORT.

WHEREAS, this Sanggunian is in receipt of a letter from the Office
of the City Mayor requesting the august body for the passage of a
resolution opposing the increase of Terminal Fee rates from P20.00 to
P150.00 at the Ormoc City Domestic Airport;

WHEREAS, at present the Ormoc City airport terminal lacks essential
amenities such as the number of restrooms, comfortable pre-departure
chairs and other improvements which have to be installed to serve the
comfort of the riding public;

WHEREAS, it is good to take note that the split type airconditioner
at the pre-departure area is donated by the local government;

WHEREAS, the Local Government of Ormoc is not totally opposed to a
reasonable increase, provided that a commensurate service is given and
that the increase should not be abrupt and exuberant;

WHEREAS, believing that said request is beneficial to the general public, the same must be given the necessary due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Member, Committee on Transportation & Communications, jointly seconded by City Councilors Fe S. Lladoc and Ruben R. Capahi; be it



ADOPTED, November 19, 2009.


