RESOLUTION APPROVING THE CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO. 2 , SERIES OF 2009, ENTITLED: "A RESOLUTION APPROVING THE AMENDMENT OF THE PROJECT ENTITLED UPDATING OF IMAGE MAP (AERIAL PHOTO) FOR ADVANCED GIS APPLICATION AND TAX MAPPING PURPOSES TO PROCUREMENT OF ORTHO RECTIFIED HIGH-RESOLUTION SATELLITE IMAGERY AND GIS REMOTE SENSING SOFTWARE AND TRAINING IN THE AMOUNT OF THREE MILLION FIFTY FIVE HUNDRED SIXTY FOUR PESOS ONE THOUSAND (P3,051,564.00) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR THE APPROVAL OF THE SAME".

WHEREAS, the project – Updating of Image Map (Aerial Photo) for Advanced GIS Application and Tax Mapping purposes was included in the CY 2002 Annual Investment Plan (AIP) of the city and was subsequently approved by the 9<sup>th</sup> Sangguniang Panlungsod ng Ormoc per SP Resolution No. 2002-012;

WHEREAS, considering that the aforementioned project has not yet been implemented the City Development Council opted to amend the same from Updating of Image Map (Aerial Photo) for Advanced GIS Application and Tax Mapping purposes to Procurement of Ortho Rectified High-Resolution Satellite Imagery and GIS Remote Sensing Software and Training which will cost P3,051,564.00;

WHEREAS, unlike the previous project which covers only the urban areas of the city, the new project will now involve the whole land area of Ormoc City at almost the same cost as the old project, hence, it is deemed more practical and advantageous to the city government;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Fernando P. Parrilla, Member, Committee on Infrastructure, severally seconded by City Councilors Mariano Y. Corro, Rafael C. Omega, Jr. and Lea Doris C. Villar; be it
