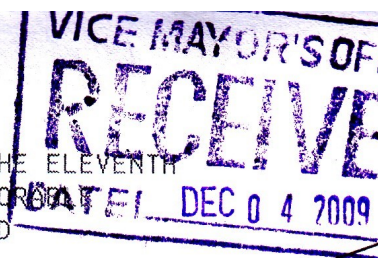

RESOLUTION NO. 2009-239

A RESOLUTION RESPECTFULLY REQUESTING THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) FOR A CLARIFICATION ON THE COVERABILITY IN THE GSIS OF CITY ELECTED OFFICIALS WHO AT THE TIME OF THEIR ELECTIONS WERE ALREADY GSIS PENSIONERS/RETIREES AND/OR OVER 65 YEARS OLD.

WHEREAS, presently there are City Councilors who at the time of their elections were already GSIS pensioners/retirees and/or over 65 years old;

WHEREAS, inspite of their aforecited status, they were still required to register anew as GSIS members, were issued insurance policies, and premium contributions were paid for and in their behalves, up to the present;

WHEREAS, these City Councilors were assured by GSIS officials from the Satellite Office in Ormoc City as well as from the Regional Office in Tacloban City of their coverability in the GSIS;

WHEREAS, these City Councilors welcomed their coverage in the GSIS because of privileges and benefits they expect to enjoy and receive;

WHEREAS, lately "talks" were heard that these City Councilors are no longer coverable in the GSIS; however, these "talks" were never confirmed by the local GSIS personnel so much so, that one of these City Councilors wrote a letter, twice, to the Customer Relation and Monitoring Department of GSIS in Pasay City, seeking a clarification on this matter, but very unfortunately, no reply was received thereto, hence, this resolution hoping that this will now merit a reply from GSIS, so that these City Councilors will have a peace of their minds and/or will be able to act accordingly;

FOREGOING, PREMISES CONSIDERED, on MASS MOTION of the Body; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) FOR A CLARIFICATION ON THE COVERABILITY IN THE GSIS OF CITY ELECTED OFFICIALS WHO AT THE TIME OF THEIR ELECTIONS WERE ALREADY GSIS PENSIONERS/RETIREES AND/OR OVER 65 YEARS OLD;
