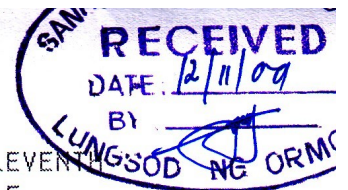


ADOPTED, December 10, 2009.
