A RESOLUTION APPROVING BARANGAY ORDINANCE NO. 2009-002 OF THE BARANGAY COUNCIL OF BARANGAY DISTRICT XXIV, THIS CITY, ENTITLED: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 001 SERIES OF 1999 - "AN ORDINANCE FIXING THE RATES OF BARANGAY CLEARANCE FEES, PERMITS, AND OTHER CHARGES AND FEES FOR THE AVAILMENT OR USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2009-002 of the Barangay Council of Barangay District XXIV, entitled: "AN ORDINANCE AMENDING SOME PROVISIONS OF BARANGAY ORDINANCE NO. 001 SERIES OF 1999 - "AN ORDINANCE FIXING THE RATES OF BARANGAY CLEARANCE FEES, PERMITS, AND OTHER CHARGES AND FEES FOR THE AVAILMENT OR USE OF VARIOUS PROPERTIES AND SERVICES OF THE BARANGAY";
