A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS FOR THE CONSTRUCTION OF MULTI-PURPOSE BUILDING (COVERED COURT PHASE I) AT BARANGAY CURVA, ORMOC CITY.

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc has received an urgent indorsement dated December 17, 2009 from the Office of the City Mayor relative to the Memorandum of Agreement by and between the City Government of Ormoc and the Department of Public Works and Highways for the construction of Multi-purpose Building (Covered Court Phase I) at Barangay Curva, Ormoc City and further requesting for authority to sign the same;

WHEREAS, the agreement covers the release, utilization and liquidation of funds for the said project to be funded by the Special Local Road Fund of DPWH with the Special Allotment Release Order (SARO) chargeable against FY 2009 RA 9574 or the General Appropriations Act of FY 2009;

WHEREAS, it was specified in the agreement that the LGU of Ormoc shall implement the project by contract thru competitive bidding subject to the policies, standards and procedures therein setforth;

WHEREAS, this august Body finds the provisions of the Memorandum of Agreement to be in order;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Jose C. Alfaro, Jr., Councilor-In-Charge, severally seconded by City Councilors Rafael C. Omega, Jr., Filomeno P. Maglasang, Mariano Y. Corro and Sotero M. Pepito; be it
