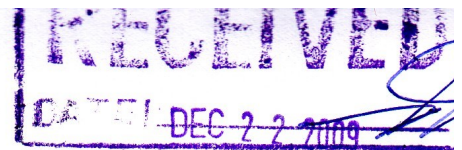

RESOLUTION NO. 2009-248

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE CONTRACT OF POWER SUPPLY BY AND BETWEEN LEYTE V ELECTRIC COOPERATIVE, INC. (LEYECO V) AND THE NEW ORMOC CITY HALL.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated December 17, 2009, from the Office of the City Mayor urgently requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign the Contract of Power Supply by and between Leyte V Electric Cooperative, Inc. (LEYECO V) and the New Ormoc City Hall;

WHEREAS, the contract of Power Supply subject for approval states that any amendment on the above contracted load shall need a written notification and request for such amendment subject to a forty five (45) days reglementary period prior to effectivity and subject further to the review and approval of the Cooperative;

WHEREAS, the said Contract also mentions of the specific obligation of both parties, under the terms and conditions agreed upon;

WHEREAS, this august Body believes that the terms and conditions of the said Contract of Power Supply is reasonable, however, the fourth paragraph of said contract should be deleted considering that the same is disadvantageous to the government, hence, the same be accorded the necessary due course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Mariano Y. Corro, Chairman, Committee on Energy Conservation, jointly seconded by City Councilors Jose C. Alfaro, Jr. and Filomeno P. Magalasang; be it



