WHEREAS, the move is directed towards efficient supervision and administration of the entire City of Ormoc;

WHEREAS, the composition of the sanggunian districts shall from time to time be determined and approved by the members of the sanggunian. Until revised, the division and composition of the Eleven (11) Sanggunian Districts are hereto attached and marked as Annex "A" of this resolution;
