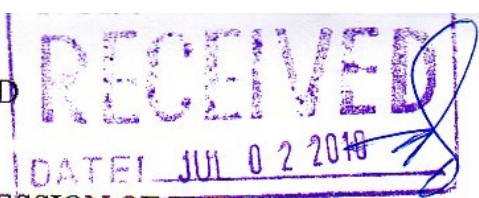

ADOPTED, June 30, 2010.


