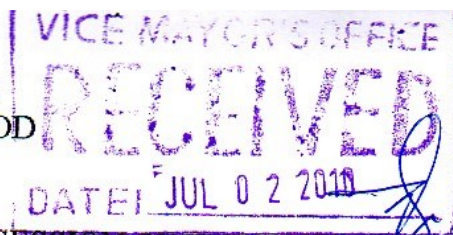


WHEREFORE , on MASS MOTION of the Body; be it
