WHEREAS Barangay Tongonan in their resolution dated May 4, 2010 and received by this Sangguniang Panlungsod on June 2, 2010 requested for an endorsement from this Sangguniang Panlungsod to the Department of Environment and Natural Resources regarding their application for Forest Land Use Agreement for Tourism (FLAgT);
