# RESOLUTION NO. 2010-014

RESOLUTION REQUESTING THE **ENVIRONMENTAL** MANAGEMENT BUREAU (EMB), REGION 8, TO CONDUCT INSPECTION/INVESTIGATION REGARDING COMPLAINT OF MR. CAMILO PATON-OG, PRESIDENT OF LEYTE FARM INDUSTRIAL LABOR AND DRIVER'S ORGANIZATION (LEFILDO) AS TO THE POLLUTION CLAIMED TO BE CAUSED BY LEYTE **AGRI** CORPORATION (LAC).

WHEREAS, the Sangguniang Panlungsod received a copy of a letter-complaint of Mr. Camilo Paton-og regarding the problem of pollution caused by the Alcohol Plant of Leyte Agri Corporation (LAC) affecting the residents of Barangay Ipil, this city;

WHEREAS, in spite of the multi-sectoral monitoring (composed of the DENR, Local and National Government Agencies, and representative from local communities) and contrary to their findings, this complaint was raised;

WHEREAS, it is claimed that this perennial problem has not been addressed to despite of several complaints;

WHEREAS, this sanggunian is recommending to the Regional Environmental Management Bureau (EMB) together with the Multi-Partite Monitoring Team (MMT) to conduct an investigation regarding the matter and forward their findings to this office within two (2) weeks after they have finished their investigation so that once and for all this problem will be resolved;



WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Environment and Natural Resources, jointly seconded by City Councilors Lea Doris C. Villar and Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING THE ENVIRONMENTAL MANAGEMENT BUREAU (EMB), REGION 8, TO CONDUCT AN INSPECTION/INVESTIGATION REGARDING THE COMPLAINT OF MR. CAMILO PATON-OG, PRESIDENT OF LEYTE FARM INDUSTRIAL LABOR AND DRIVER'S ORGANIZATION (LEFILDO) AS TO THE POLLUTION CLAIMED TO BE CAUSED BY LEYTE AGRI CORPORATION (LAC);
