RESOLUTION NO. 2010-018

A RESOLUTION TO TAKE NOTE AND INTERPOSE NO OBJECTION TO
THE BARANGAY RESOLUTION NO. 9, SERIES OF 2010 OF
BARANGAY CATMON, THIS CITY, ENTITLED: "A RESOLUTION
INTERPOSING NO OBJECTION FOR THE CONSTRUCTION AND TO
OPERATE OF A TUNNEL VENTILATION TYPE POULTRY AT PUTOK
(SIC) 2 OF BARANGAY CATMON, ORMOC CITY.

WHEREAS, this sanggunian received a resolution from the Barangay Council of
Catmon, this city, entitled: "A RESOLUTION INTERPOSING NO OBJECTION FOR THE
CONSTRUCTION AND TO OPERATE OF A TUNNEL VENTILATION TYPE POULTRY
AT PUTOK (SIC) 2 OF BARANGAY CATMON, ORMOC CITY.

WHEREAS, the proposed poultry project is owned by AOG Enterprises which has
already an existing poultry farm at Barangay Valencia, Ormoc City;

WHEREAS, last June 20, 2010 a public hearing was called by Hon. Fortunato T. Ycoy,
Barangay Chairman of Barangay Catmon, in the presence of other barangay officials and well-
attended by the barangay residents, for the purpose of evaluating the housekeeping practices of
the poultry farm;

WHEREAS, as presented therein, AOG Enterprises will use modern technology known
as "tunnel type ventilation poultry" which was proven to be effective in controlling and
minimizing the possible ill effects resulting from the poultry operation especially with regards
to smell and flies;

WHEREAS, the common concern of the barangay residents during the consultation was
in relation to housekeeping and maintenance of the project. Considering that the proponent uses
modern technology in keeping up the poultry and accord primary concern on the health condition
of the people, it was the consensus to allow AOG Enterprises to proceed with the project;

WHEREAS, however, the poultry project is subject to and shall conform with the provisions of the Environmental Compliance Certificate (ECC) ;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Lea Doris C. Villar, Vice-Chairman, Committee on Environment and Natural Resources, jointly seconded by City Councilors Filomeno P. Maglasang and Ruben R. Capahi ; be it




