RESOLUTION NO. 2010-020

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
ERIC C. CODILLA TO ENTER INTO AND SIGN THE  
MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF  
OF THE CITY GOVERNMENT OF ORMOC WITH THE  
DEPARTMENT OF AGRICULTURE- REGIONAL FIELD UNIT NO.  
VIII (DA-RFU 8) FOR THE UNDERTAKING OF THE SUB-PROJECT  
ENTITLED: ESTABLISHMENT OF ONE (1) UNIT AGRICULTURAL  
TRAMLINE IN BARANGAY CABINTAN, THIS CITY.

WHEREAS, this sanggunian received an urgent indorsement dated July 20, 2010 from the Office of the City Mayor in connection with the Memorandum of Agreement (MOA) to be entered into by the Local Government Unit of Ormoc with the Department of Agriculture-Regional Field Unit No. VIII (DA-RFU8) for the undertaking of the sub-project, entitled: Establishment of One (1) Unit Agricultural Tramline in Barangay Cabintan, this city.

WHEREAS, the said agreement was the subject of an indorsement dated July 20, 2010 from the Officer-In-Charge of City Agricultural Services Office (CASO), Dr. Joseph C. Cortes, which stated that the deadline for the submission of the MOA will be on July 23, 2010 otherwise the project will be forfeited.



WHEREAS, the aforementioned sub-project is worth One Million Five Hundred Fifteen Thousand (P1,515,000.00) Pesos which shall be allocated by the Department of Agriculture to carry out the purpose and consequently will be disbursed as grant to LGU-Ormoc to finance the said project, subject to the terms and conditions provided in the Memorandum of Agreement;

WHEREAS, the undertaking is in consonance with the Department of Agriculture- GOAL 2 Program Thrust which involves the development, application and provision of improved agri-fishery post-harvest systems that will develop the handling and movement of high value agricultural produce to step up the efficiency of supply chain logistics.

WHEREAS, this august Body find the provisions of the Memorandum of Agreement to be in order and the same is deemed beneficial to the people hence, the requested authority of the Honorable City Mayor to sign the same necessitates immediate action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture and Fisheries, jointly seconded by City Councilors Rafael C. Omega, Jr. and Ruben R. Capahi; be it


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this sanggunian for information and file;

ADOPTED, July 22, 2010.


