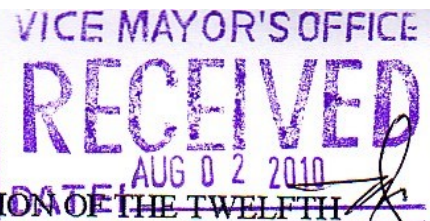

RESOLUTION NO. 2010-024

A RESOLUTION SUPPORTING THE PROPOSED REGROUPING OF
THE SCHOOLS IN ORMOC CITY DIVISION INTO SIX (6) SCHOOL
DISTRICTS.

WHEREAS, this sanggunian is in receipt of an indorsement from the Office of the City Mayor dated July 21, 2010 requesting for appropriate action on the request of Ms. Sol C. Lumarda, Schools Division Superintendent, Ormoc City Division to approve at the soonest possible time a resolution supporting the proposed regrouping of the schools in Ormoc City Schools Division into six (6) school districts ;

WHEREAS, the move is a division level initiative to effect a reorganization of the City Schools Division towards sharing of authority, power and influence in appropriate levels ;

WHEREAS, the proposed reorganization of the Ormoc City Schools Division by increasing the number of school districts from four (4) to six (6) would drastically reduce the school administrator - teacher ratio thus, making the administration and supervision of schools and instruction more efficient and effective ;

WHEREAS, the restructuring of the school districts is further justified by the increasing enrolment and population in all the schools within the geographical jurisdiction of the Department of Education (DepEd), Ormoc City Division. Such increase in school enrolment correspondingly requires an increase in the number of teachers to handle the additional classes organized ;
