A RESOLUTION ADOPTING THE MASTER PLAN OF THE JOINT
AGREEMENT BETWEEN JICA AND THE REPUBLIC OF THE
PHILIPPINES FOR THE PROJECT FOR STRENGTHENING MATERNAL
& CHILD HEALTH SERVICES IN EASTERN VISAYAS MORE
PARTICULARLY IN ORMOC CITY.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated July 27, 2010 from the Office of the City Mayor relative to the letter of Dr. Nelita D. Navales, City Health Officer II, urgently requesting for the passage of a resolution adopting the Master Plan of the joint agreement between JICA and the Republic of the Philippines for the project for Strengthening Maternal & Child Health Services in Eastern Visayas more particularly in Ormoc City;

WHEREAS, the purpose of adopting the Master Plan of the above-mentioned project is to increase the pregnant women and newborns receiving the safe pregnancy, safe delivery and postpartum care services in the target area of Eastern Visayas;

WHEREAS, said agreement mentions that JICA will provide the services of the Japanese experts, provide such machinery and equipment and will receive the Philippine personnel connected with the Project for technical training in Japan;

WHEREAS, the Government of the Republic of the Philippines will ensure that the technologies and knowledge acquired by the Philippine nationals as a result of Japanese technical cooperation will contribute to the economic and social development of the Republic of the Philippines.

WHEREAS, the said joint agreement also stipulates the specific obligation of both parties, under the terms and conditions agreed upon;

WHEREAS, this august Body finds the said Agreement as just reasonable and beneficial to the general public, hence, the same should be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Rafael C. Omega, Chairman, Committee on Health & Sanitation, duly seconded City Councilor Claudio P. Larrazabal; be it
