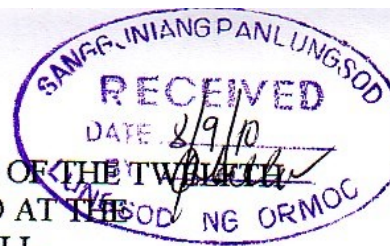

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH MR. EDUARDO J. DAGPIN, PROPRIETOR, ORMOC BINGO SOCIAL, FOR THE MANAGEMENT AND OPERATION OF BINGO GAMES AT THE 2<sup>ND</sup> FLOOR, NEW ORMOC CITY PUBLIC MARKET GRAND CENTRAL BUILDING A, THIS CITY.

WHEREAS, the Twelfth Sangguniang Panlungsod ng Ormoc received an indorsement dated July 6, 2010 from the Office of the City Mayor in connection with the Memorandum of Agreement to be entered into by the City Government of Ormoc with Mr. Eduardo J. Dagpin, Proprietor, Ormoc Bingo Social, for the management and operation of Bingo Games in the city and further requesting that the Honorable City Mayor shall be authorized to sign the same;

WHEREAS, Mr Eduardo J. Dagpin was awarded a provisional Grant of Authority (GOA) to operate Traditional Bingo Games by the Philippine Amusement and Gaming Corporation (PAGCOR) subject to the full compliance with the PAGCOR Regulatory Orders and Bingo Gaming Procedural Guidelines;

WHEREAS, upon proper evaluation of the provisions of the Memorandum of Agreement, this sanggunian finds that the terms and conditions embodied therein are reasonable and that the subject Bingo Games shall be operated on the basis of responsible gaming solely for recreational and amusement purposes;


