RESOLUTION NO. 2010-032

**A RESOLUTION REQUIRING ALL BUSINESS ESTABLISHMENTS IN
THE CITY OF ORMOC TO REGISTER WITH THE PAG-IBIG FUND
AS PROVIDED FOR UNDER REPUBLIC ACT NO. 9679.**

WHEREAS, this Sanggunian is in receipt of a communication from the Pag-IBIG Fund dated July 5, 2010 requesting for support in the implementation of Republic Act No. 9679 known as the "Home Development Mutual Fund Law of 2009", otherwise known as Pag-IBIG (Pagtutulungan sa Kinabukasan: Ikaw, Bangko, Industriya at Gobyerno) Fund, through local legislation requiring both employer and employee in the government and private sectors to register with the Fund for membership for the institutionalized savings program of the government;

WHEREAS, the foregoing request needs local government support considering that it is for the purpose of implementing a national law;

WHEREAS, to promote business registration and information in the City of Ormoc the sharing of data-base (on-line) between Pag-IBIG and the Business Permit, Licensing and Franchising Office (BPLFO) of the city is encouraged;

WHEREAS, as part of the Business Permit Streamlining Program of the city, the Pag-IBIG Fund shall coordinate with the Business Permit, Licensing and Franchising Office (BPLFO) of Ormoc City in setting up a business One-Stop-Shop at the New City Hall to facilitate the processing of business permits;

WHEREAS, the National Economic Research and Business Assistance Center (NERBAC) has already been established at the New City Hall through the BPLFO- Ormoc and Pag-IBIG Fund can avail of its services;

WHEREAS, the institutionalization of NERBAC in the city through BPLFO will make easier and faster for prospective investors, entrepreneurs and other business establishments to secure the necessary documents for their business operation;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Filomeno P. Maglasang, Chairman, Committee on Cooperative, Trade, Commerce & Industry, jointly seconded by City Councilors Sotero M. Pepito and Ruben R. Capahi; be it


