A RESOLUTION AUTHORIZING THE CITY MAYOR ERIC C.
CODILLA, TO SIGN THE CONTRACT OF CONSULTANCY
OF ATTY. MARIANO Y. CORRO.

WHEREAS, this Sanggunian received an indorsement dated July 20, 2010 from the Office of the City Mayor in connection with the Contract of Consultancy to be made and entered into by the City Government of Ormoc with Atty. Mariano Y. Corro and further requesting that the Honorable City Mayor shall be authorized to sign the said Contract;

WHEREAS, the subject of the Contract was to engage the services of Atty. Mariano Y. Corro as Legal Consultant of the City Government of Ormoc starting August 1, 2010 until December 31, 2010 ;

WHEREAS, the hiring of Atty. Corro as consultant on legal matters and/or affairs of the city is deemed necessary considering that at present the regular position of City Legal Officer is vacant;

WHEREAS, Atty Mariano Y. Corro is a member of good standing of the Philippine Bar, a former Legal Officer of the SSS Regional Office in Cebu City, and is a former Councilor of Ormoc City for Fifteen (15 years) and is therefore considered conversant with the administration and governance of LGUs in general and the City of Ormoc in particular;

WHEREAS, the consultancy services of Atty. Corro is subject to the terms and conditions set forth in the contract;

WHEREAS, this august Body find the provisions of the Consultancy Contract to be in order hence, the requested authority of the Honorable City Mayor to sign the same necessitates immediate action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Good Government, severally seconded by City Councilors Jose C. Alfaro, Jr., Sotero M. Pepito and Rafael C. Omega, Jr. ; be it


ADOPTED, August 12, 2010.

RESOLVED, FURTHER, that a copy of the final and notarized Contract of Consultancy be submitted to this sanggunian for information and file;


