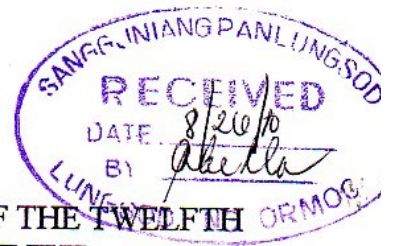

RESOLUTION NO. 2010-044

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
ERIC C. CODILLA TO SIGN THE CONTRACT OF CONSULTANCY  
(RENEWAL) OF DR. SAMUEL S. GO AS CONSULTANT FOR  
AGRICULTURE.

WHEREAS, this Sanggunian received an indorsement dated July 6, 2010 from the Office of the City Mayor relative to the Contract of Consultancy (Renewal) to be made and entered into by the City Government of Ormoc with Dr. Samuel S. Go and further requesting that the Honorable City Mayor shall be authorized to sign the said Contract;

WHEREAS, it can be recalled that Dr Samuel S. Go was a Consultant of the City Government of Ormoc for matters, activities, programs and plans for our City Agricultural Services Office since 2004. The latest contract covering his consultancy services was for the period January 1, 2010 to June 30, 2010 which was approved by the Eleventh Sangguniang Panlungsod ng Ormoc per SP Res. No. 2010-015;

WHEREAS, the preceding consultancy contract of Dr. Go had already expired last June 30, 2010 and considering that the LGU of Ormoc City desires to continuously engage his services as Consultant on Agriculture, it is deemed necessary that a renewal contract shall be made and executed by the concerned parties;



WHEREAS, the Consultancy Contract subject for approval states that Dr. Samuel S. Go shall act as Consultant on Agriculture for a period of six (6) months starting July 1, 2010 to December 31, 2010, subject to the terms and conditions therein set forth ;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Good Government, severally seconded by City Councilors Lea Doris C. Villar, Rafael C. Omega, Jr., Jose C. Alfaro, Jr. and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN THE CONTRACT OF CONSULTANCY (RENEWAL) OF DR. SAMUEL S. GO AS CONSULTANT FOR AGRICULTURE.


ADOPTED, August 24, 2010.

RESOLVED, FURTHER, that a copy of the final and notarized Contract of Consultancy be submitted to this sanggunian for information and file;


