A RESOLUTION APPROVING THE PROPOSED TICKET PRICES FOR THE COMING " SEMI-FINALS AND FINALS " OF THE ORMOC CITY INTER-SCHOOLS BASKETBALL LEAGUE TO BE HELD AT THE ORMOC CITY SUPERDOME ON SEPTEMBER 4-5, 2010 (SEMI-FINALS) AND ON SEPTEMBER 8-12, 2010 (FINALS).

WHEREAS, this Sanggunian received a communication dated August 23, 2010 from the Ormoc City Sports Office requesting approval on their intention to sell tickets for the coming Semi-Finals and Finals" of the Ormoc City Inter-Schools Basketball League to be held at the Ormoc City Superdome on September 4-5, 2010 (Semi-Finals) and on September 8-12, 2010 (Finals) respectively;

WHEREAS, the said sports activity is initiated by the Ormoc City Government through the City Sports Council in cooperation with the Ormoc City Schools Sports Organization(OCSSO);

WHEREAS, the basketball games will be participated in by the different public and private schools within the city and the championships thereof will consist of three (3) categories which are : Elementary- Best of Three(3); Secondary- Best of Five (5); Collegiate- Best of Five (5); with a Special Championship for the lowest ranked Three (3) Teams in the Collegiate Division;

WHEREAS, the undertaking is geared towards promoting camaraderie among the youth and develop prospective athletes in the city;

WHEREAS, in order to defray the possible expenses that will be incurred during the tournament, the local organizers intend to sell tickets for the championship games at the following prices:

P 15.00	Courtside	(Green Seats)
10.00	Upper Box	(Yellow Seats)
5.00	General Admission	

WHEREAS, it is the intention of the City Sports Council and the OCSSO to provide non-cash incentives to the different participating schools, which items are to be procured from out of the proceeds of the tickets. It is understood that after paying all the necessary expenses related to the activity including the 10% Superdome Obligation, the remaining Net Balance on the proceeds of ticket sales, as the case may be, shall be turned over to the City Treasury and a Financial Statement relative thereto shall be submitted to the concerned agencies for information;

WHEREAS, as required under Ordinance No. 64, Series of 1997, otherwise known as "AN ORDINANCE GOVERNING THE OPERATION AND MANAGEMENT OF THE ORMOC CITY SUPERDOME, AND THE FIXING OF THE RENTALS, FEES AND OTHER CHARGES FOR THE USE THEREOF", the permission of the Sangguniang Panlungsod is needed, hence this request from the Ormoc City Sports Council;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Ruben R. Capahi, Chairman, Ormoc City Sports Council, duly seconded by City Councilor Sotero M. Pepito; be it


