WHEREAS, this Sanggunian received an Indorsement dated August 19, 2010 from the Honorable City Mayor Eric C. Codilla requesting for the passage of a resolution authorizing His Honor to enter into and sign the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and Mr. Gino Maginoo A.
