A RESOLUTION AUTHORIZING THE HONORABLE CITY  
MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE  
MEMORANDUM OF AGREEMENT (RENEWAL) BY AND  
BETWEEN THE CITY GOVERNMENT OF ORMOC  
THROUGH THE CITY HEALTH DEPARTMENT AND SAN  
LORENZO RUIZ COLLEGE OF ORMOC, INC.

WHEREAS, this Sanggunian received an indorsement dated September 14, 2010 from the Office of the City Mayor relative to the renewal of the Memorandum of Agreement by and between the City Government of Ormoc thru the City Health Department and San Lorenzo Ruiz College of Ormoc, Inc., and further requesting that the Honorable City Mayor shall be authorized to sign the same;

WHEREAS, the agreement refers to the continuance of partnership of the above parties in providing community-based work in health-related services as practicum for Medical Technology students of San Lorenzo Ruiz College of Ormoc, Inc.;

WHEREAS, under the agreement the City Government of Ormoc through the City Health Department shall make available the organized community health services at San Pablo District Health Center for the necessary learning experience of Medical Technology students of San Lorenzo Ruiz College of Ormoc, Inc. on community health under the supervision of a licensed Medical Technologist who shall act as Clinical Instructor and will assist the students on the duration of their practicum, subject to the terms and conditions therein set forth;



WHEREAS, the Memorandum of Agreement covers a period of One (1) year starting September, 2010 until October, 2011 and may be renewed upon mutual understanding of both parties;

WHEREAS, this august Body finds the stipulations of the agreement to be in order hence, the requested authority of the Honorable City Mayor to sign the same necessitates due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Rafael C. Omega, Jr., Chairman, Committee on Health, duly seconded by City Councilor Corinne M. Corro; be it


ADOPTED, September 30, 2010.
