

## **RESOLUTION NO. 2010-064**

A RESOLUTION APPROVING THE "CITIZEN'S CHARTER" OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY IN COMPLIANCE WITH THE PROVISIONS OF R.A. 9485, OTHERWISE KNOWN AS THE "ANTI-RED TAPE ACT OF 2007", PARTICULARLY SECTION 6 THEREOF.

WHEREAS, the 12<sup>th</sup> Sangguniang Panlungsod ng Ormoc received an indorsement from the City Administrator, Dr. Dennis Y. Capuyan, in connection with the proposed "Citizen's Charter" of LGU-Ormoc which was formulated in accordance with the provisions of RA 9485, otherwise known as the "Anti-Red Tape Act of 2007" particularly Section 6 thereof and in Rule IV of its Implementing Rules and Regulations;

WHEREAS, the Anti-Red Tape Act of 2007 is directed towards promoting transparency in all government agencies and instrumentalities with regard to the manner of transacting with the public by means of establishing an effective system and practices aimed at averting graft and corruption;

WHEREAS, Sec.6 of RA 9485 provides that all government agencies or local government units shall set up their respective service standards to be known as the "Citizen's Charter" in the form of information billboards which should be posted at the main entrance of offices or at the most conspicuous place, and in the form of published materials which in effect will make known to the public the service standards to be observed in all government transactions;



WHEREAS, the strict implementation of the Anti-Red Tape Act of 2007 in all LGUs is also a directive from the Department of the Interior and Local Government (DILG);

WHEREAS, for the purpose of implementing the above law, the Citizen's Charter of LGU-Ormoc was formulated in line with the objectives of RA 9485 and with the goal of optimizing the city's economic growth potential through effective and efficient system of dispensing government services to the public;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Good Government, duly seconded by City Councilor Lea Doris C. Villar; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE "CITIZEN'S CHARTER" OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY IN COMPLIANCE WITH THE PROVISIONS OF R.A. 9485, OTHERWISE KNOWN AS THE "ANTI-RED TAPE ACT OF 2007", PARTICULARLY SECTION 6 THEREOF;

ADOPTED, September 30, 2010.
