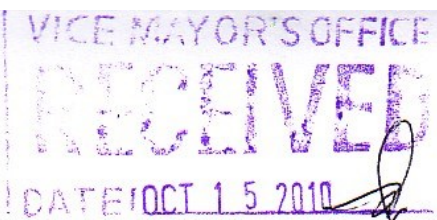

RESOLUTION NO. 2010-075

A RESOLUTION AUTHORIZING THE CITY TREASURER TO
SET-UP AND MAINTAIN A SPECIAL TRUST ACCOUNT WITH
LAND BANK OF THE PHILIPPINES FOR THE HEALTH
SYSTEM DEVELOPMENT PROGRAM (HSDP) FUND
TRANSFERS FROM THE DEPARTMENT OF HEALTH (DOH).

WHEREAS, this Sanggunian is in receipt of an Indorsement dated October 06, 2010 from the Office of the City Mayor relative to the letter of Dr. Nelita D. Navales, City Health Officer II, urgently requesting for the passage of a resolution authorizing the City Treasurer to set-up and maintain a Special Trust Account with Land Bank of the Philippines for the Health System Development Program (HSDP) Fund transfers from the Department of Health (DOH);

WHEREAS, the Center for Health Development of Eastern Visayas through a communication dated October 01, 2010 stated that their office has already processed cash transfer and now ready for release. Anent to that, the Local Government Unit has to submit a Special Trust account name and its corresponding Account Number in Land Bank of the Philippines to carry out the purpose of implementing the health programs, projects and activities that promote the health and well being of the general public;

WHEREAS, the Fund Transfer is in line with mandate of the Department of Health (DOH) to assist the LGUs in the effective implementation of health programs and to address operational issues by systematizing transfer of resources that shall be used primarily to leverage LGU performance based on the City-wide Investment Plan for Health (CIPH);


