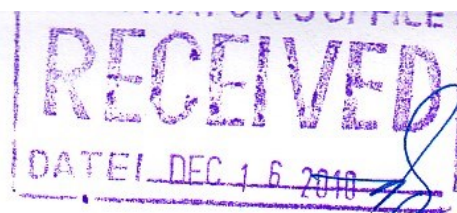

RESOLUTION NO. 2010-105

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO SIGN THE REVISED MEMORANDUM OF
AGREEMENT (MOA) BY AND BETWEEN THE LOCAL
GOVERNMENT UNIT OF ORMOC AND DEPARTMENT OF
AGRICULTURE- REGIONAL FIELD UNIT NO. VIII (DA-RFU 8) FOR
THE UNDERTAKING OF THE SUB-PROJECT ENTITLED:
ESTABLISHMENT OF ONE (1) UNIT AGRICULTURAL TRAMLINE
IN BARANGAY CABINTAN, THIS CITY.

WHEREAS, this sanggunian received an indorsement dated December 8, 2010 from the Office of the City Mayor in connection with the communication coming from Mr. Joseph C. Cortes, OIC, City Agricultural Services Office, requesting for the amendment of the Memorandum of Agreement (MOA) by and between the Local Government Unit of Ormoc and the Department of Agriculture- Regional Field Unit No. VIII (DA-RFU8) for the undertaking of the sub-project, entitled: Establishment of One (1) Unit Agricultural Tramline in Barangay Cabintan, this city;

WHEREAS, the subject Memorandum of Agreement was earlier approved by this sanggunian per SP Resolution No. 2010-020 dated July 22, 2010;

WHEREAS, as provided for in No. 2 of General Provisions under Article I of the approved MOA, the undertaking of the sub-project shall be completed on or before December 15, 2010;

WHEREAS, in order to give ample time to the concerned parties to fully comply with the necessary requirements stipulated in the agreement, it is deemed appropriate and reasonable that the above provision shall be amended as proposed by Mr. Cortes;

WHEREAS, in connection thereto, No. 2 of the General Provisions under Article I of the said Memorandum of Agreement is hereby amended and shall now read as follows:

ARTICLE I
GENERAL PROVISIONS

2. The Sub-Project shall be completed on or before June 30, 2011.

WHEREAS, all other provisions of the Agreement which are not affected by this amendment shall remain to be in force and in effect;

WHEREFORE, foregoing premises considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture and Fisheries, severally seconded by City Councilors Corinne M. Corro, Ruben R. Capahi and Rafael C. Omega, Jr.; be it




