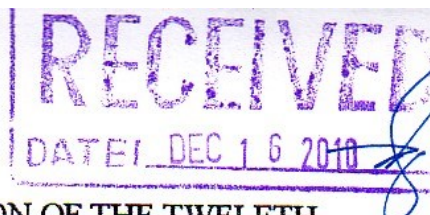

RESOLUTION NO. 2010-106

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR
ERIC C. CODILLA TO SIGN A CONTRACT OF USUFRUCTUARY
WITH WAIVER OF RIGHTS WITH A MEMORANDUM OF
AGREEMENT TO BE ENTERED INTO BY AND BETWEEN THE
BUREAU OF FISHERIES AND AQUATIC RESOURCES-REGIONAL
OFFICE NO. VIII (BFAR-RFU 8) AND THE CITY GOVERNMENT OF
ORMOC, FOR THE CONSTRUCTION AND ESTABLISHMENT OF
ORMOC FRESHWATER FISH HATCHERY AND NURSERY PROJECT
AND BFAR8 WESTERN LEYTE PROVINCIAL FISHERY OFFICE.

WHEREAS, this Sanggunian is in receipt of an Indorsement dated December 03, 2010, from the Office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to sign a Contract of Usufructuary with Waiver of Rights with a Memorandum of Agreement to be entered into by and between the Bureau of Fisheries and Aquatic Resources- Regional Office No. VIII (BFAR-RFU 8) and the City Government of Ormoc, for the construction and establishment of Ormoc Freshwater Fish Hatchery, Nursery Project and BFAR Western Leyte Provincial Fishery Office situated at the Integrated Agri-Fisheries Demo Farm, Slaughter House Complex, Barangay Macabug, Ormoc City;

WHEREAS, the contract stipulates that both parties agreed that the USUFRUCTUARY shall waive, renounce, and /or quitclaim, any and all improvements that maybe existing at the time of expiry date of this contract, including the building that may have been constructed thereon in favor of the OWNER, who in turn shall be the exclusive and absolute owner of the same and also stated that the term of this agreement shall only be for a period of twenty five(25)years from and after execution of this instrument, renewable upon mutual agreement of the parties;

WHEREAS, the above parties have entered into this undertaking with the general aim of achieving food security and protection of fishery resources in order to provide the food needs of the population to the issues on scarcity of fish which has greatly affected the attainment of fish self sufficiency in the country;

WHEREAS, the said Contract and Memorandum of Agreement also mentions the specific obligation of both parties, under the terms and conditions agreed upon;

WHEREAS, this august body believes that the terms and conditions of the said Contract and Memorandum of Agreement is beneficial to the fish farmers and the general public hence, the same be accorded the necessary due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, duly seconded City Councilor Rafael C. Omega, Jr.; be it




