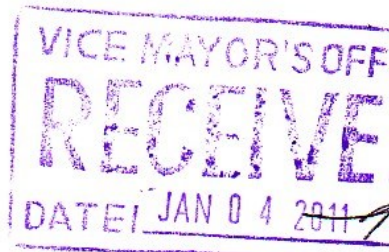

RESOLUTION NO. 2010-114

A RESOLUTION AUTHORIZING THE CITY VICE MAYOR, NEPOMUCENO P. APARIS I, TO SIGN THE CONTRACT OF CONSULTANCY OF ATTY. MARIANO Y. CORRO AS LEGISLATIVE CONSULTANT OF THE SANGGUNIANG PANLUNGSOD, THIS CITY.

WHEREAS, the Twelfth Sangguniang Panlungsod ng Ormoc as the legislative body of the city shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the city pursuant to Section 16 of the Local Government Code of 1991 and in the proper exercise of the corporate powers of the city as provided for under Section 22 of the Code for the efficient and effective city government;

WHEREAS, it is well acknowledged that how the sanggunian optimizes its legislative competence is both a measure and an indication of quality legislation which can be achieved in a situation where policy making capabilities of the sanggunian are sufficiently addressed;

WHEREAS, it is in such basis that this august Body desires to employ the services of Atty. Corro as consultant on legislative masters and/or affairs of the 12th Sangguniang Panlungsod. The move is in consonance with the thrust of the Body to enhance its legislative procedures through the assistance of Atty. Corro and to continuously provide a better quality legislation to the Ormocanons;

WHEREAS, Atty. Mariano Y. Corro is a member of good standing of the Philippine Bar, a former Legal Officer of the SSS Regional Office in Cebu City, a former Councilor of Ormoc City for fifteen (15) Years, and is currently the Legal Consultant of the City of Ormoc whose consultancy services will expire on December 31, 2010 and is therefore considered conversant with the administration and governance of LGUs in general and the City of Ormoc in particular;

WHEREAS, the consultancy services of Atty. Corro at the Sangguniang Panlungsod will commence on January 1, 2011 until December 31, 2011, and is subject to the terms and conditions set forth in the contract copy of which is hereto attached and made an integral part hereto;
