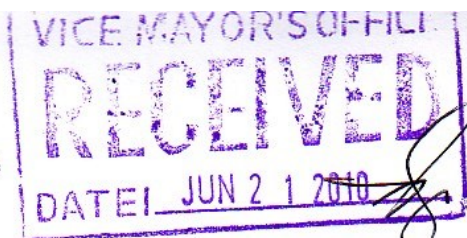



ADOPTED, June 17, 2010.


