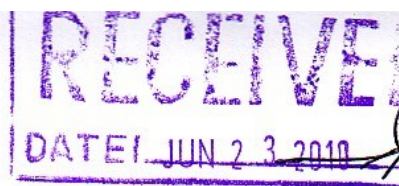

RESOLUTION NO. 2010-121

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO
CHARGE AGAINST CURRENT APPROPRIATION THE CLAIMS OF
HON. CLINTON C. NUEVO, PRESIDING JUDGE, RTC BRANCH 12,
THIS CITY, IN THE TOTAL AMOUNT OF TWELVE THOUSAND
TWO HUNDRED SEVENTY FIVE PESOS (P12,275.00), BROKEN
DOWN AS FOLLOWS:

ADDITIONAL ALLOWANCE (DECEMBER, 2009) - P2,300.00
REIMBURSEMENT OF TRAVELING EXPENSES
(DECEMBER 1-10, 2009) - 9,975.00

WHEREAS, this Sanggunian received an indorsement dated April 30, 2010 from the Office of the City Mayor in connection with the letter of Hon. Clinton C. Nuevo, Presiding Judge, RTC Branch 12, this city, requesting to claim his Monthly Allowance from the city government for the month of December, 2009 in the amount of P2,300.00 as well as the reimbursement of his traveling expenses incurred while attending the "Orientation Seminar for Newly Appointed Judges" in Manila last December 1-10, 2009 amounting to P9,975.00;

WHEREAS, in the same indorsement from the Office of the City Mayor, it is further requested that the City Accountant be given authority to charge the aforementioned claims of Hon. Clinton C. Nuevo against the current appropriation considering that the said object of expenditures is still a part of the Year 2009;

WHEREAS, the Office of the City Budget Officer, through an indorsement dated May 27, 2010 reiterated the request of the Office of the City Mayor stating therein that the City Accountant be given authority to charge the said obligation against the current appropriation of the city;

WHEREAS, in a separate indorsement dated May 27, 2010, the City Treasurer stated that funds are available under the current appropriation which may be used to cover the said claims provided that the City Accountant shall be authorized to charge the same;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, jointly seconded by City Councilors Sotero M. Pepito and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST CURRENT APPROPRIATION THE CLAIMS OF HON. CLINTON C. NUEVO, PRESIDING JUDGE, RTC BRANCH 12, THIS CITY, IN THE TOTAL AMOUNT OF TWELVE THOUSAND TWO HUNDRED SEVENTY FIVE PESOS (P12,275.00), BROKEN DOWN AS FOLLOWS:
