A RESOLUTION RATIFYING THE AUTHORITY TO UTILIZE ONE HUNDRED TWENTY THOUSAND PESOS (P120,000.00) MORE OR LESS FROM THE 5% CALAMITY FUND OF THE CITY OF ORMOC BY THE HONORABLE CITY MAYOR ERIC C. CODILLA AS CHARMAN OF THE CITY DISASTER RISK REDUCTION MANAGEMENT COUNCIL OF ORMOC FOR RELIEF AND OPERATIONAL EXPENSE.

WHEREAS, there has been a disaster of massive proportion in St. Bernard, Southern Leyte;

WHEREAS, massive flooding and landslide occurred due to incessant and abnormal rainfall thus resulting to three (3) deaths damages to properties which later called for a declaration of state of calamity by the national government;
