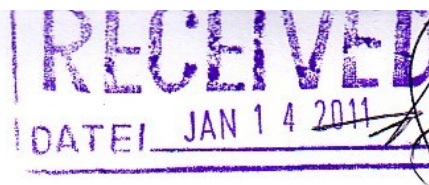

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR  
ERIC C. CODILLA TO SIGN THE CONTRACT OF CONSULTANCY  
(RENEWAL) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF  
ORMOC WITH DR. SAMUEL S. GO AS CONSULTANT FOR  
AGRICULTURE.

WHEREAS, this Sanggunian received an indorsement dated December 23, 2010 from the Office of the City Mayor relative to the Contract of Consultancy (Renewal) to be made and entered into by the City Government of Ormoc with Dr. Samuel S. Go and further requesting that the Honorable City Mayor be authorized to sign the said Contract;

WHEREAS, it can be recalled that Dr. Samuel S. Go has been a Consultant of the City Government of Ormoc since 2004 for matters, activities, programs and plans for our City Agricultural Services Office. The latest contract covering his consultancy services was for the period July 1, 2010 to December 31, 2010 which was approved by this august Body per SP Res. 2010-044;

WHEREAS, the preceding consultancy contract of Dr. Go having already expired last December 31, 2010 and considering that the LGU of Ormoc City desires to continuously engage his services as Consultant on Agriculture, it is deemed necessary that a renewal contract be made and executed by the concerned parties;

WHEREAS, the Consultancy Contract subject for approval states that Dr. Samuel S. Go shall act as Consultant on Agriculture for a period of One (1) Year starting January 1, 2011 to December 31, 2011, subject to the terms and conditions therein set forth;

RESOLVED, FURTHER, that a copy of the final and notarized Contract of Consultancy be submitted to this Sanggunian for information and file;


