## RESOLUTION NO. 2011-008

RESOLUTION REQUESTING THE DEPARTMENT OF TRANSPORTATION AND COMMUNICATION FOR THE REMOVAL OF THE COMMUNICATION ANTENNA TOWER AND THE ACCESSORY GUY WIRES, LOCATED AT THE ABANDONED TELECOMMUNICATION OFFICE IN FRONT OF THE NEW ORMOC CITY HIGH SCHOOL IN AUNUBING STREET.

WHEREAS, there is an existing tower which was utilized as mounting for the antenna of the Telecommunication Office which was abandoned some time in the nineteen nineties and is presently used as class rooms by EVSU;

WHEREAS, one of the guy wires/buntings of the said tower crosses the street leading to the sidewalk beside the New City Hall creating traffic and vehicular hazard;

WHEREAS, the vehicular flow of traffic in the above mentioned street is increasing because of people transacting business with the different offices thereat;

WHEREAS, it is of paramount importance that the subject tower and guy wire be removed for the safety of commuters and pedestrians in particular and the whole community in general;
