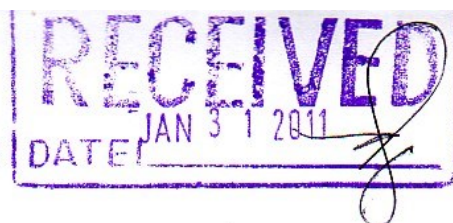

RESOLUTION NO. 2011-016

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE SUPPLEMENTAL SERVICE LEVEL AGREEMENT, CY 2010 UNIVERSAL HEALTH INSURANCE PROGRAM GRANT FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT-EASTERN VISAYAS AND PHILIPPINE HEALTH INSURANCE CORPORATION-EASTERN VISAYAS FOR THE IMPLEMENTATION OF THE ANNUAL OPERATIONAL PLAN (AOP) 2010 OF THE CITY-WIDE INVESTMENT PLAN FOR HEALTH(CPIH).

WHEREAS, this Sanggunian is in receipt of an Indorsement dated January 11, 2011 from the office of the City Mayor requesting for the passage of a resolution authorizing the Honorable City Mayor Eric C. Codilla to enter into and sign the Supplemental Service Level Agreement, CY 2010 Universal Health Insurance Program Grant for and in behalf of the City Government of Ormoc with the Department of Health-Center for Health Development-Eastern Visayas and Philippine Health Insurance Corporation-Eastern Visayas for the Implementation of the Annual Operational Plan (AOP) 2010 of the City-Wide Investment Plan for Health (CPIH);

WHEREAS, the National Health Insurance Act of 1995 (Republic Act No. 7875 as amended by Republic Act No. 9241) mandates for a universal health insurance coverage for all Filipinos as a means to provide financial risk protection, especially for the poor.



WHEREAS, the Supplemental Service Level Agreement covers the management and implementation of the Universal Health Insurance Coverage through enrolment of indigents in the Sponsored Program Component of the National Health Insurance Program in terms of ensuring availment of benefits by informing families of their entitlements and responsibilities;

WHEREAS, finding the terms and conditions of said Agreement beneficial to the underprivileged and indigent families to be in order, this sanggunian believes that the requested authority by Honorable City Mayor to sign the same be given due course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of the City Councilor Refael C. Omega, Jr.; Committee on Health and Sanitation, severally seconded by City Councilors Sotero M. Pepito, Jose C. Alfaro, Jr. and Demosthenes F. Tugonon; be it


ADOPTED, January 27, 2011.

RESOLVED, FURTHER, that a copy of the final and notarized Agreement be submitted to this sanggunian for information and file;


