RESOLUTION NO. 2011-021

RESPECTFULLY URGING CONGRESS OF THE RESOLUTION PHI IPPINES TO AMEND REPUBLIC ACT NO. 9994, OTHERWISE KNOWN AS "THE EXPANDED CITIZENS ACT OF 2010" BY EXEMPTING FROM THE VALUE ADDED TAX (VAT), APPLICABLE, ALL PURCHASES OF GOODS AND SERVICES, SUBJECT TO DISCOUNT, BY SENIOR CITIZENS.

WEEREAS, the enactment of REPUBLIC Act No. 9994, otherwise known as the "Expanded Senior Citizens Act of 2010" is most welcomed and appreciated by the Senior Citizens, as it provided additional benefits and privileges to them;

WHEREAS, one of the most significant changes of the law is the exemption from VAT of certain purchases of goods and services by Senior Citizens;

WHEREAS, there are certain purchases by Senior Citizens which are discounted but subject to VAT, hence the benefit accorded to them is not full and complete. Example: Purchase of basic necessities and prime commodities subject to a five (5%) percent discount WITHOUT EXEMPTION from VAT. (Joint DTI-DA Administrative Order No. 10-02, Series of 2010, Section 3 thereof);

WHEREAS, it is incomprehensible, illogical unreasonable that the 5% discount given to Senior Citizens on their purchase of basic necessities and prime commodities is subject to VAT, while the 20% discount on the purchase of medicine, etc. (Section 4, par. (a) of Rep. Act No. 9994), is EXEMPT from VAT, considering further that there is no material and substantial differences of the same that justify its non inclusion in the VAT Exempt items;



WHEREAS, the aforecited situation brings confusion, discrimination and misapprehension to our Senior Citizens, and might have likewise infringed on uniformity of taxation, hence must be corrected;

WHEREAS, it is prayed that there must be uniformity and consistency in the implementation of the law, especially on social legislation, like the EXPANDED SENIOR CITIZENS ACT OF 2010, otherwise, the law may seemingly appear to be violative of the equal protection clause of the 1987 Philippine Constitution;

WHEREAS, it is further that there must be a comprehensive exemption from VAT, if applicable, on ALL PURCHASES of goods and services by senior citizens subject to discount, if only to harmonize and equalize the application thereof;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Lea Doris C. Villar, Chairman, Committee on Social Services, Senior Citizen, Women and Family, severally seconded by City Councilors Claudio P. Larrazabal, Mario M. Rodriguez and Corinne M. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY URGING CONGRESS OF THE PHILIPPINES TO AMEND REPUBLIC ACT NO. 9994, OTHERWISE KNOWN AS "THE EXPANDED CITIZENS ACT OF 2010" BY EXEMPTING FROM THE VALUE ADDED TAX (VAI), IF APPLICABLE, ALL PURCHASES OF GOODS AND SERVICES, SUBJECT TO DISCOUNT, BY SENIOR CITIZENS;
