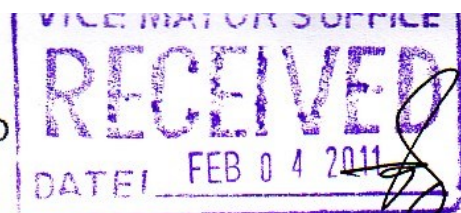

RESOLUTION NO. 2011-024

A RESOLUTION CONCURRING WITH THE APPOINTMENT OF
ATTY. AUGUSTINE M. VESTIL, JR. AS CITY LEGAL OFFICER
FOR THE CITY GOVERNMENT OF ORMOC EFFECTIVE
FEBRUARY 1, 2011.

WHEREAS, the Twelfth Sangguniang Panlungsod ng Ormoc received a communication from the Office of the City Mayor with respect to the appointment of Atty. Augustine M. Vestil, Jr. to the position City Legal Officer for the City Government of Ormoc City effective February 1, 2011;

WHEREAS, Section 454 Paragraph (D) of Chapter 2 (City Officials in General) of RA 7160, otherwise known as the Local Government Code of 1991, provides that:

"X X X, heads of departments and offices shall be appointed by the City Mayor with the concurrence of the majority of the Sangguniang Panlungsod Members, subject to civil service law rules and regulations. X X X X"(Underscoring supplied).

WHEREAS, upon evaluation of the documents and other pertinent records submitted, this august Body finds that the appointee, Atty. Augustine M. Vestil, Jr., has satisfactorily met the qualification standards set for the position of City Legal Officer and the appointment made by the Honorable City Mayor is in accordance with existing civil service law, rules and regulations;
