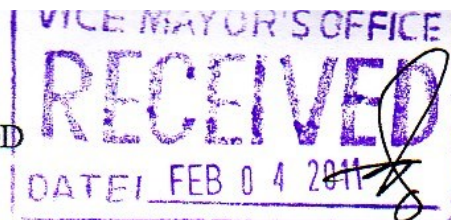

RESOLUTION NO. 2011-025

A RESOLUTION CONCURRING WITH EXECUTIVE ORDER NO.06, S. 2011 DATED JANUARY 28, 2011 OF THE HONORABLE CITY MAYOR ERIC C. CODILLA, ENTITLED: "AN ORDER ORGANIZING A SPECIAL COMMITTEE FOR THE PROPOSED TRANSFER OF THE MANAGEMENT AND OPERATIONS OF THE ORMOC DISTRICT HOSPITAL (ODH) FROM THE PROVINCE OF LEYTE TO ORMOC CITY".

WHEREAS, this august Body received a communication dated February 1, 2011 from the Office of the City Mayor anent the Executive Order No.06, S. 2011 of the Honorable City Mayor Eric C. Codilla, entitled: "AN ORDER ORGANIZING A SPECIAL COMMITTEE FOR THE PROPOSED TRANSFER OF THE MANAGEMENT AND OPERATIONS OF THE ORMOC DISTRICT HOSPITAL (ODH) FROM THE PROVINCE OF LEYTE TO ORMOC CITY";

WHEREAS, the Special Committee created by the Honorable City Mayor under Executive Order No. 06 shall represent and will serve as official panel of the City Government of Ormoc during consultation meeting(s) and negotiations with designated officials/representatives from the Province of Leyte to discuss and prepare the necessary documentation and other terms of reference and agreements in relation to the proposed transfer of the management and operations of the Ormoc District Hospital ;



WHEREAS, the proposed transfer of the management and operations of the Ormoc District Hospital from the Province of Leyte to the City Government of Ormoc is deemed a practical alternative to the early plans of the present administration to establish a city hospital considering the possible technical complications and huge financial requirement of the project;
