RESOLUTION NO. 2011-028

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO DONATE AND SIGN THE DEED OF DONATION OF A PORTION OF A PARCEL OF LAND LOCATED AT BARANGAY CABINTAN TO CABINTAN ELEMENTARY SCHOOL WITH AN AREA OF THREE THOUSAND SEVEN HUNDRED FIFTY EIGHT SQ.M. (3,758 SQ.M.) AND TO CABINTAN NATIONAL HIGH SCHOOL WITH AN AREA OF FOUR THOUSAND FOUR HUNDRED EIGHTY NINE SQ. M. (4,489 SQ.M.) OR A TOTAL OF EIGHT THOUSAND SIXTY SIX SQ. M. (8,066 SQ.M).

WHEREAS, this Sanggunian is in receipt of a Local School Board Resolution No. 2011-03 dated January 21, 2011 a resolution endorsing the request of the Barangay Council of Cabintan, for Sangguniang Panlungsod to authorize the City Mayor to donate a portion of a parcel of land located at Brgy. Cabintan to Cabintan Elementary School with an area of Three Thousand Seven Hundred Fifty Eight sq.m.(3,758 sq.m.) and to Cabintan National High School with an area of Four Thousand Four Hundred Eighty Nine sq.m.(4,489 sq.m.) or a total of Eight Thousand Sixty Six sq.m.(8,066 sq.m.);

WHEREAS, the aforementioned Local School Board Resolution refers to the establishment of Cabintan National High School to have its own school site and since Cabintan Elementary School occupied an area more than enough for its needs a parcel of Four Thousand Four Hundred Eighty Nine sq. m. (4,489 sq. m.) can be given for the operation of a National High School;

WHEREAS, as cited in the said Deed of Donation, the Donor (City Government of Ormoc) voluntarily and freely gives, transfers and conveys by way of donation unto Donee (Department of Education DepEd) a parcel of land covered by Tax Declaration No. 00012-00014, Cadastral Lot No. 10851 containing an area of Eight Thousand Sixty Six sq. m. (8,066 sq.m.) free from all liens and encumbrances of any kind and nature whatsoever saving and excepting those created by operation of law;

WHEREAS, as provided for in the deed of donation that the parcel of land donated shall be utilized for the Barangay Cabintan Elementary School Site and Barangay Cabintan National High School site;

WHEREAS this august body finds all provisions of the Deed of Donation as just and reasonable, hence the requested authority by the Honorable City Mayor to donate and sign the same, be accorded the necessary course of action;

WHEREFORE, foregoing premises considered, on joint motion of the City Councilor Demosthenes F. Tugonon, Chairman Committee on Public Properties and City Councilor Filomeno P. Maglasang Chairman Committee on Education, severally seconded by City Councilors Jose C. Alfaro, Jr., Rafael C. Omega, Jr. and Mario M. Rodriguez; be it


