# RESOLUTION NO. 2011-036

A RESOLUTION AUTHORIZING THE CITY MAYOR OF ORMOC, HON. ERIC C. CODILLA TO SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) TO BE ENTERED INTO BY AND BETWEEN THE LOCAL GOVERNMENT OF THE PROVINCE OF LEYTE REPRESENTED BY HON. JERICHO L. PETILLA, LEYTE PROVINCIAL GOVERNOR, AND THE LOCAL GOVERNMENT OF THE CITY OF ORMOC REPRESENTED BY HON. ERIC C. CODILLA, CITY MAYOR, REGARDING THE PROPOSED TRANSFER AND TURN OVER OF THE MANAGEMENT, OPERATIONS, OWNERSHIP AND ADMINISTRATION OF THE ORMOC DISTRICT HOSPITAL FROM THE PROVINCE OF LEYTE TO THE CITY OF ORMOC.

WHEREAS, the Twelfth Sangguniang Panlungsod ng Ormoc received an Indorsement dated February 21, 2011 from the Office of the City Mayor urgently requesting this Sanggunian to pass a resolution authorizing the Honorable City Mayor Eric C. Codilla to sign the Memorandum of Understanding (MOU) by and between the Local Government of Ormoc City and the Local Government of the Province of Leyte relative to the proposed transfer and turn over of the management, operations, ownership and administration of the Ormoc District Hospital from the Province of Leyte to the City of Ormoc.

WHEREAS, the undertaking is a manifestation of the mutual desire and firm commitment of both parties to ensure and effect a smooth and effective transfer and turn over of the management, operations, ownership and administration of the Ormoc District Hospital from the Province of Leyte to the City of Ormoc.
