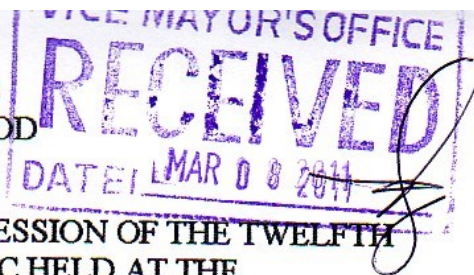

A RESOLUTION SUPPORTING THE FORMATION OF THE LOCAL  
HEALTH ACCOUNTS (LHA) TEAM OF LGU-ORMOC AS  
PROVIDED FOR IN ADMINISTRATIVE ORDER NO.2009-0026  
DATED DECEMBER 29, 2009 OF THE DEPARTMENT OF HEALTH  
(DOH).

WHEREAS, this Sanggunian received an indorsement dated February 28, 2011 from the Office of the City Mayor relative to the communication of Dr. Nelita D. Navales, City Health Officer II, requesting this august Body for the passage of a resolution supporting the formation of the City Local Health Accounts (LHA) Team of LGU-Ormoc;

WHEREAS, the formation of the City Local Health Account Team is in accordance with the provisions of DOH Administrative Order No. 0026 dated December 29, 2009 which subject is the Implementing Guidelines for Institutionalizing the Estimation and Use of Local Health Accounts(LHA);

WHEREAS, the DOH Regional Director Edgardo M. Gonzaga through a communication dated February 8, 2011 also enjoins the city government to form a Local Health Account Team to undertake the LHA estimation which is in consonance with the ongoing efforts of the DOH to institutionalize LHA estimation as a tool for improving local health system performance;

WHEREAS, this august Body believes that the move is beneficial and advantageous to the city government hence, deserving of full support from this august Body;
