A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (RENEWAL) BY AND BETWEEN THE CITY GOVERNMENT OF ORMOC THROUGH THE CITY HEALTH DEPARTMENT AND SAN LORENZO RUIZ COLLEGE OF ORMOC, INC.

WHEREAS, the Twelfth Sangguniang Panlungsod ng Omoc received an indorsement dated March 3, 2011 from the Office of the City Mayor relative to the renewal of the Memorandum of Agreement by and between the City Government of Ormoc thru the City Health Department and San Lorenzo Ruiz College of Ormoc, Inc., and further requesting that the Honorable City Mayor be authorized to sign the same;

WHEREAS, the agreement subject for renewal refers to the continuation of the involvement of Nursing Students of San Lorenzo College Of Omoc, Inc., in providing community health services to the Ormocanons as part of their school curriculum, through the facilities and services of the City Health Department;

WHEREAS, it can be recalled that the previous Memorandum of Agreement between the City Government of Ormoc through the City Health Department and San Lorenzo Ruiz College of Ormoc, Inc. in relation to the community health services of its Nursing Students was passed and approved on December 13, 2007 as embodied in SP Resolution No. 2007-124 wherein it was specified that the duration of the agreement was good for Three (3) years only;

WHEREAS, in view of the expiration of the preceding agreement, there is a need for the above parties to enter into a new undertaking in relation to the matter hence, this request;

WHEREAS, the new Memorandum of Agreement covers a period of Three (3) years, to commence immediately upon the execution thereof ;

WHEREAS, the participation of the Nursing Students of San Lorenzo College of Ormoc, Inc. in the implementation of the community health services programs and projects at the different District Health Centers of the city is subject to the terms and conditions set forth in the agreement;

WHEREAS, this august Body finds the stipulations of the agreement to be in order hence, the requested authority of the Honorable City Mayor to sign the same necessitates due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Vice-Chairman, Committee on Health, severally seconded by City Councilors Sotero M. C. Pepito, Filomeno P. Maglasang and Mario M. Rodriguez; be it


ADOPTED, March 15, 2011.
