## **RESOLUTION NO. 2011-053**

A RESOLUTION APPROVING THE PROPOSED DIVERSION ROAD PROJECT TO BE CONSTRUCTED FROM BARANGAY SAN PABLO TO BARANGAY BANTIGUE, THIS CITY, TO BE FUNDED BY THE NATIONAL GOVERNMENT.

WHEREAS, the Twelfth Sangguniang Panlungsod ng Omoc received a communication dated February 28, 2011 from the Office of the City Mayor in connection with the letter-request of Engr. Lino Francisco C. Gonzales, OIC-District Engineer, 4<sup>th</sup> Leyte Engineering District, for a resolution approving the construction of a diversion road from Barangay San Pablo to Barangay Bantigue, this city, and further recommending that favorable action be accorded on the matter;

WHEREAS, the proposed diversion road has an approximate length of fifteen (15) kilometers and will be undertaken and implemented by the Department of Public Works and Highways (DPWH);

WHEREAS, the resolution requested from this Sanggunian is a requisite prior to the project implementation and the passage thereof is anchored on the fact that the City of Ormoc has an existing City Ordinance No. 53, S. 1995, entitled: "AN ORDINANCE IMPLEMENTING THE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991(R.A. NO. 7160) REQUIRING MANDATORY COORDINATION AND CONSULTATION WITH THE APPROPRIATE LOCAL **GOVERNMENT** UNITS, NON-GOVERNMENTAL PEOPLE'S ORGANIZATIONS AND OTHER CONCERNED SECTORS, AND APPROVAL OF THE SANGGUNIANG **PANLUNGSOD** NG **ORMOC** PRIOR THE IMPLEMENTATION OF NATIONALLY FUNDED PROJECTS/PROGRAMS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF";



WHEREAS, the proposed diversion road project is deemed a Nationally Funded Project hence, it is necessary that the appropriate approval from this sanggunian shall be obtained through a resolution before the DPWH can proceed with the project implementation in consonance with the provisions of RA 7160 and City Ordinance No. 53;

WHEREAS, this august Body believes that the request is meritorious and the proposed project is deemed beneficial to the City of Ormoc;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion presented by City Councilor Filomeno P. Maglasang, Vice-Chairman, Committee on Infrastructure Development, severally seconded by City Councilors Jose C. Alfaro, Jr., Sotero M. Pepito and Corinne M. Corro, Rolando M. Villasencio and Mario M. Rodriguez; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING THE PROPOSED DIVERSION ROAD PROJECT TO BE CONSTRUCTED FROM BARANGAY SAN PABLO TO BARANGAY BANTIGUE, THIS CITY, TO BE FUNDED BY THE NATIONAL GOVERNMENT;

ADOPTED March 15, 2011;
