NEGOTIATION AGREEMENT (CNA) WITH THE PROPOSED
AMENDMENTS BETWEEN THE CITY GOVERNMENT OF ORMOC
AND THE CITY OF ORMOC GOVERNMENT EMPLOYEES
ASSOCIATION (COGEA).

WHEREAS, this Sanggunian is in receipt of an Indorsement dated February 07, 2011 from the Office of the City Mayor relative to the proposed amendments of the Collective Negotiation Agreement (CNA) to be entered into by the City Government of Ormoc and the City of Ormoc Government Employees Association (COGEA);

WHEREAS, in an Indorsement from the Hon. Mariano Y. Corro, Legal Consultant of the City Government of Ormoc dated November 11, 2010 we are informed that the existing Collective Negotiation Agreement (CNA) already expired last July 31, 2010 and there is now a proposal for certain amendments to be introduced by the City of Ormoc Government Employees Association (COGEA);

WHEREAS, the COGEA is the sole representative of the government employees to negotiate and undertake activities not contrary to law or public policy and has initiated efforts to propose certain amendments to the existing Collective Negotiation Agreement, to foster and maintain good relationship between the employees and management;

WHEREAS, after the review and evaluation on the corrections and inputs proposed by the special committee created by the management, the said proposed amendments are found to be all fair and reasonable hence, the same is to be accorded due course of action;
