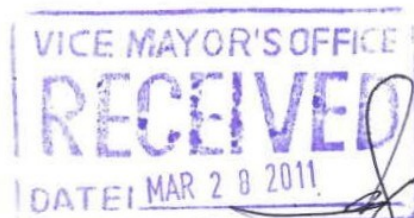

OF ORMOC AND THE DEPARTMENT OF SOCIAL WELFARE AND
DEVELOPMENT- FIELD OFFICE VIII FOR THE IMPLEMENTATION
OF SEA PROGRAM OF THE DEPARTMENT OF SOCIAL WELFARE
AND DEVELOPMENT(DSWD).

WHEREAS, this Sanggunian received an indorsement from the Office of the City Mayor dated March 2, 2011 anent the Memorandum of Agreement (MOA) to be entered into by the City Government of Ormoc with the Department of Social Welfare and Development- Field Office VIII for the implementation of SEA Program of DSWD;
