OF AGREEMENT (MOA) BY AND AMONG THE ATENEO DE
MANILA UNIVERSITY (ADMU), THE ORMOC CITY SCHOOLS
DIVISION (OCSO) AND THE LOCAL GOVERNMENT OF ORMOC
(LGU-ORMOC) FOR THE SUPPORT OF THE CITY TO THE TWO
HUNDRED TWELVE (212) TEACHERS AND OTHER SCHOOL
OFFICIALS' PARTICIPATION IN THE TEMASEK FOUNDATIONS'
