RESOLUTION NO. 2011-069

A RESOLUTION DESIGNATING THE CITY LEGAL OFFICER TO ACT
AS HEARING OFFICER OF THE LOCAL LAND TRANSPORTATION
FRANCHISING AND REGULATORY BOARD (LTFRB) FOR
MOTORIZED TRICYCLES, SUBJECT HOWEVER, TO REVIEW AND
APPROVAL OF THE SANGGUNIANG PANLUNGSOD NG ORMOC.

WHEREAS, the regulation of tricycles for hire is a devolved function from the LTFRB to the local sanggunian. The matter took effect upon the implementation of RA 7160 such that the registration and grant of franchise to tricycles for hire is vested in the legislative body;

WHEREAS, currently the Hearing Officer of the Local Land Transportation Franchising and Regulatory Board (LTFRB) for Motorized Tricycles is Mr. Emilio G. Tingson, Licensing Officer IV of the Permits, Licenses and Franchising Division, as authorized in SP Resolution No. 2010-022 dated February 4, 2010;

WHEREAS, it can be recalled that the City Legal Officer normally acted upon as the Hearing Officer for the applications of Motorized Tricycles Operators' Permit (MTOP) subject however, to review and approval of the Sangguniang Panlungsod as embodied in SP Resolution No. 73 dated September 24, 1992;

WHEREAS, considering that the position of City Legal Officer was left vacant for a significant period, the preceding sanggunian resolved to delegate Mr. Tingson as the Hearing Officer for the Local LTFRB for Motorized Tricycles as contained in SP Resolution No. 2010-022 so that the delivery of public services will not be hampered;

WHEREAS, recently, the LGU of Ormoc City acquired the services of Atty. Augustine M. Vestil, Jr. as the new City Legal Officer and his appointment to the position was concurred by this august Body per SP Resolution No. 2011-024 dated February 3, 2011.

WHEREAS, it is deemed appropriate that the new City Legal Officer will be delegated to act as the Hearing Officer of the Local LTFRB for Motorized Tricycles, hence, the passage of this resolution;




